Doyle Street Pool



The following policies and procedures are enforced for the SAFETY and ENJOYMENT of all patrons.

General Policies:

- Children 6 years and under, non-swimmers, and children in personal floatation devices (life jackets) must be
 accompanied and within arm's reach, in the water, by an adult (16 & over) at all times.
- Children 6-11 years old must be supervised at the facility by an adult (16 & over).
- Unaccompanied minors (ages 12-17) must provide emergency contact information at the check-in desk.
- Everyone must walk on the pool deck.
- Diving is not permitted in either pool.
- Horseplay, sitting or standing on one another's shoulders, piggy backs, throwing each other, pushing, dunking, wrestling, excessive splashing, yelling, hanging and climbing on features is not permitted.
- The use of tobacco products is prohibited on the grounds, parking lot included.
- Non swimmers or weak swimmers must remain in the activity pool. A swim test is required to enter the lap pool for anyone under 4 ft.
- Appropriate and modest swim wear as determined by Doyle Street pool staff is required for pool entry. Cut-off jeans, underwear and see-thru swim wear is not permitted. T-shirts that are not offensive may be worn over swimsuits.
- All non-toilet trained children must wear a swim diaper.
- All patrons must shower thoroughly before entering the pool.
- Personal floatation devices (life jackets) must be United States Coast Guard approved. Rental PFD's are available for a fee.
- Snorkels, fins, inner tubes, toys, rafts, noodles, and other floatation devices may not be used in the pool during Open Swim hours.
- No outside food and beverages are permitted with the exception of bottled water. Items purchased at the concession stand may not be consumed within 5 feet of the pool.
- Patrons who consistently disruptive to others or do not follow pool policies and procedures may be asked to leave the premises without a refund or raincheck.
- All patrons are responsible for following the whistle commands of the lifeguards.
 1 shot blast =attention 1 long blast = all patrons must exit the pool.

Lap Pool:

- Lap lanes are dedicated to lap swimming only and can be reserved for 30 minute increments.
- A swim test is required to enter the lap pool for anyone under 4 ft. The test will consist of swimming half-way across the width of the pool, treading water for 30 seconds, and then finish swimming to the other side of the pool.
- Swimmers may jump from the side of the pool but cannot take a running start and should make sure the area is clear before jumping.
- Swimmers are not permitted to hang on lane ropes.

Feature Pool:

- Standing on or jumping from the S-wall is not permitted.
- Children 6 years and under, non-swimmers, and children in personal floatation devices (life jackets) must be
 accompanied and within arm's reach, in the water, by an adult (16 & over) at all times.

Weather:

- In the event of a tornado warning, the facility will close immediately and all patrons will be asked to leave.
- In the event of a severe thunder storm or a tornado watch, patrons will be asked to exit the water and wait inside the pool house until lifeguards re-open the pool or the facility is closed.
- No refunds or rainchecks will be issued due to weather delays or closures.
